DIRECTIONS

From Montclair:

1. Start out going WEST on ESSEX WAY toward PARK ST.
2. Turn RIGHT onto PARK ST.
3. Turn RIGHT onto CR-655/WATCHUNG AVE.
4. Merge onto GARDEN STATE PKWY N via the ramp on the LEFT (Portions toll).
5. Merge onto I-80 E via EXIT 159 toward I-95/NEW JERSEY TURNPIKE/G. WASHINGTON BR.
6. Merge onto I-95 N/NEW JERSEY TURNPIKE N via the exit on the LEFT toward G WASHINGTON B/NEW YORK.
7. Keep RIGHT to take I-95 N/NEW JERSEY TURNPIKE N toward G W BRIDGE LOWER LEVEL/US-1 N/US-9 N.
8. Take EXIT 73 toward RT-67/FORT LEE.
9. Turn LEFT onto CENTER AVE.
10. Turn RIGHT onto BRIDGE PLZ N.

From Manhattan:

1. Start out going SOUTHWEST on BROADWAY toward W 44TH ST.
2. BROADWAY becomes 7TH AVE/TIMES SQ.
3. Turn RIGHT onto W 42ND ST.
4. Turn RIGHT onto 12th Ave/Ny-9a N/West Side Hwy. Continue to follow NY-9A N.
5. Take the I-95 exit, EXIT 14, toward Geo Washington Br/Cross Bronx Expwy/W 178 St.
6. Merge onto I-95 S/US-1 S/US-9 S via the exit on the LEFT toward G W BRIDGE/NEW JERSEY/UPPER LEVEL (Crossing into NEW JERSEY).
7. Take EXIT 73 toward RT-67/US-9W/FORT LEE/PALISADES PKWY.
8. Take the HUDSON TERRACE ramp toward FORT LEE.
9. Turn LEFT onto CR-505/HUDSON TER.
10. Turn LEFT onto MERKLE ST.
11. Turn LEFT onto N CENTRAL RD.
12. Turn RIGHT onto BRIDGE PLZ N.

From Route 80 East:

Take the I-95 N exit 68B to New York, keep following signs, then merge onto I-95 N/New Jersey Turnpike N then take exit 73 Route 67 to Fort Lee. Make a left onto Center Ave and then a right onto Bridge Plaza

From 95N/ New Jersey Turnpike North:

Follow Directions for Route 80 East
